437 NCAA DII Student Athletes (2024-25)

M/W Cross Country, Football, M/W Soccer, Volleyball, M/W Basketball, Baseball, Softball, M/W Indoor and Outdoor Track & Field, Cheer (275 male/162 female)

- 51% White/Non-Hispanic, 20% Two or More, 13% Black, 11% Hispanic, 4% Native Hawaiian, 1% Native American (self reported on NCAA compliance survey)
- 52% Resident, 42% WUE, 6% Non-Resident
- Class Standing: 27% First-Year, 26% Second-Year, 23% Third-Year,
 20% Fourth-Year, 4% Fifth/Sixth Year



Diversity in WOU Athletics

The WOU Athletic teams are made up of people from diverse backgrounds. **Of the 437 student athletes, 49% identify as non-white** (Two or more, Black, Hispanic, Native Hawaiian or Native American). Percentage of student athletes within the total university population (Fall 2024):

- 4.92% identify as Hispanic (48)
- 10.14% identify as White/Non Hispanic (223)
- **52.12%** identify as Black (57)
- 31.21% identify as Native Hawaiian (18)
- 8.74% identify as Native American (4)
- 35.97% identify as two or more races (87)

Athletics provides a route for historically underrepresented students to continue their education at an affordable cost so it is important to preserve these opportunities for students.

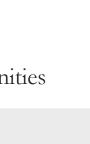

Athletics Funding Sources

IFC (FY25 - \$925,048)

Student fee. Historically covered travel and operating expenses but with decreased enrollment it is no longer able to cover full cost

General fund (FY25 - \$5,119,999)

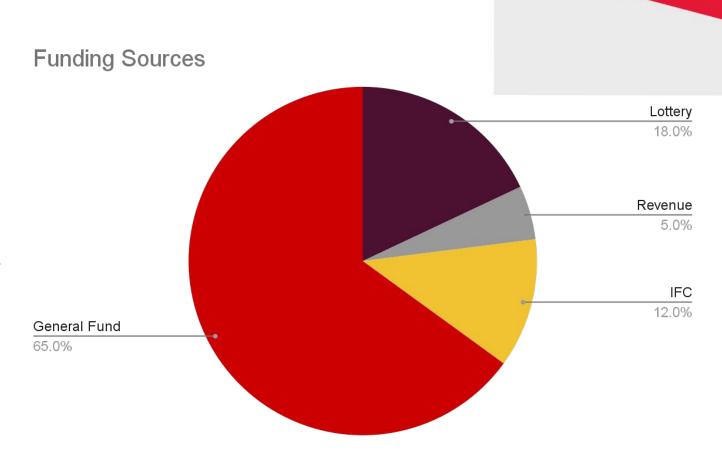
Covers salaries, benefits and other payroll expenses for admin, head and assistant coaches. Any additional amount is used to cover operating and travel expenses not covered by incidental fee

Lottery (FY25 - \$1,396,015)

Primarily used for scholarships

Revenue (FY24 - \$404,195)

Camps, game guarantees, ticket sales, concessions, royalties

Athletics Travel

Transportation- Rental vehicles, Charter Bus service, Air travel & Baggage fees

Lodging- Overnight accommodations at away competitions

Meals- Provided on away trips for team members

Entry Fees- Some events charge an entry fee for participation



Example Trip: Volleyball GNAC Game

The team flew to Fairbanks on 9/25, left WOU at 4am to get on a cheap early morning flight at 7am, Fairbanks to Anchorage on 9/27, Anchorage to home on 9/29, left Anchorage to PDX at 1:30am to land at 6am to avoid additional costs. Total of 18 people traveling.

Flights cost: \$12,405.60

Transportation from WOU to PDX and PDX to WOU: \$1,671.00

Rental car cost: \$1,339.11. Purchase gas for the car: \$71.30

GNAC requires certain **hotels** which are usually the cheapest. In total the hotels cost \$3,874.

Food/Meals: \$3,343.48 total (business office policies would allow them to spend \$5,760). It really was a 4-day trip getting back at 6am so they spent \$46.44 per person per day.

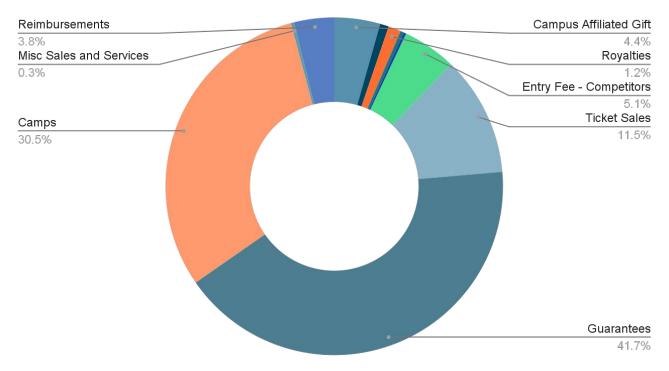
In total this trip came to \$22,811.11

Why has our financial need increased?

The addition of a men's soccer program in FY23

The addition of 30-40 new students at WOU

Football joining the Lone Star Conference as an affiliate member in FY23

Increased travel but more visibility for WOU, more recruitment opportunities

Everything costs more...Inflation

Airline tickets, bus/van rentals, fuel, food, lodging, equipment, uniforms, insurance

In FY18 the Athletics department received \$1,285,657 in IFC funding with 321 student athletes.

This year, FY25, the Athletic departments allocation was \$925,048 with 437 student athletes.

Don't forget about inflation! The inflation rate between 2018-2024 was 24.82% (US Bureau of Labor Stats)





FY26 Athletics IFC Funding Request

FY25 Current Service Level: \$925,048

FY26 Request: \$925,048 (CSL) + \$46,252 (enhancement) = \$971,300

Enhancement Request: 5% increase: \$46,252

Reduction scenario: -5% decrease: \$46,254 and -10% decrease: \$92,504

- An **increase** in funding will help bring us closer to our projected travel costs of \$1,626,000 for FY26 and allow us to allocate self funded dollars more strategically towards student scholarships rather than supplementing travel expenses.
- A decrease in funding will widen the gap between actual operation expenses and our current funding.
