 - b. Additionally, for clubs and how they run, what information should be provided so they can know about the ongoing changes and requests that the IFC has done up so far?
 - c. I've gotten questioned about certain parts of online classes and the money that's gone into that, such as health care tuition; what other parts do they pay for? and what parts do need to be looked into if they aren't being utilized because they are online students? Should they be provided a better comprehension on how they could utilize the resource that they pay for?
 - d. As a Senator for ASWOU, I've gone to multiple clubs, and enhancements are always a thing that gets brought up, but not enough information is being provided to them that gives them enough of a grasp on the inner workings—what can be changed for that or what can we do to facilitate those changes.
