- 4. IFC Travel Fund Request
  - Women's+ Rugby Club
    - i. Rhylie: We have an Extraordinary Travel request from the Women's+ Rugby Team and it need to be heard today.
    - ii. Nic: As a club sport we are mainly funded by IFC and we greatly appreciate all the funding that we get. Goal as a club sport have changed we went to national last year and this year and budget is stressed out. Between all the cost, it goes really quickly. We had an undefeated fall and spring season. We started fundraising but fell short. It is about a \$15,000 trip for 2 coached and 11 players. We



are hoping to be considered for the extraordinary travel funds. Funds is for player benefits. They have done everything.
