Old Business

- □ Interpretation for 5% increase threshold Craig Ashford
 - Evan: General council has a different interpretation than the IFC has used in the past for the 5% threshold that the BOT has to have review authority.
 - Craig: 3 categories: Tuition, University mandatory enrollment fee, mandatory Incidental Fee. Who came up with the fee: student body - mandatory incidental fee, University - mandatory enrollment fee. Question on how much incidental fee can increase year over year.
 - Rhylie: With the referendum of the turffield, the question is how much can we increase the fee?
 - Paula: IFC interpreted the 5% not for the fee but for the entire budget.
 - Craig: IFC understood it to be the fee and tuition could not go up by more than 5%? There is a separate limit for tuition and incidental fees.
 Subsection 2C gives the basis the board and president can reject fees that students adopt.
 - Rip: Campus Rec has the fee and turf field referendum and not known to us that this would affect the incidental fee.
 - Maggie: ASWOU had no idea but glad we can get it clarified.
 - Ema: Total amount cannot go over 5%?
 - Greg: Correct, all student initiated mandatory Incidental fees cannot increase more than 5%. University can deny it, if more than 5%.
 - Evan: Important this year. We have an enrollment drop. Keep services we need to increase the fee.
- Clarification of "Member of Household".
 - IFC Bylaws Article VII, Section I conflict of interest
 - Maggie: No voting member of IFC or IFC sub-committee member shall use their position to obtain financial gain for themselves, for any member



of their household, or for any specific Western Oregon University organization with which they are associated. Such action will be construed as a conflict of interest.

• A member of the household is a relative, not a roommate.
