Review of Minutes:

- Mark Lilley made the motion to approve, Mike Hanson seconded.

Building Fire Life Safety Inspections: Jessica Olson

Extinguisher Issues:

- Not all extinguishers being checked monthly.
- SSC, RWEC, ITC Furniture placed in front of some extinguishers.
- Smith Hall Items stored under AED.

Fire System Issues:

- Hamersly Edwards heat sensors are recalled and out of date.
- Elevator inspector advises elevator 1-shot heat detectors need to be replaced with testable devices.
- MNB Smoke detector in 108 did not pass testing.

Fire Door Issues:

- Library first floor elevator fire door not closing during fire alarm testing.
- Maaske Air pressure in the building prevents some doors from closing on their own. Found fire doors propped open on first floor.

Electrical Issues:

- MNB Toaster oven and electric kettle plugged into power strip.
- Maaske Emergency light in south stairwell needs replaced.

Tipping Hazards:

NCAA Clubhouse – Metal cabinet in soccer hallway needs secured.

Holes in Walls/Ceilings:

- Maaske Ceiling tiles missing in 115 and connected side room. Ceiling tile missing in 107.
- Hamersly Ceiling tile missing in 215.

Slip/Trip Hazards:

• APSC – Concrete pad sinking at west entrance, causing trip hazard.

Other:

• NCAA Clubhouse – Soccer hallway blocked with large items. Cardboard is now making it difficult to maneuver.

Injury Review: 8 this month, 4 completed.

Description	Findings	Recommendations
The student employee advised that they leaned on the edge of a table. When the table tilted, the employee unexpectedly put weight on their right knee, causing it to lock up slightly. The employee advised that they were okay at the time, with a pain level of two out of ten, but started to feel pain at a four out of ten about an hour later while walking. They advised that they did not treat the injury, and by Sunday, they felt mostly back to normal. The student employee advised that while moving dining tables back into place, they smashed their right little finger between tables. They buddy taped the affected pinky to their right ring finger but did not treat the injury with ice. They did not leave early or miss work. The employee advised that at the time of impact, their pain level was a four out of ten. They did not experience swelling or bruising but did have some discomfort for 1.5 weeks. The student employee reported they injured their left middle finger while stacking trays during a dishwashing shift at Valsetz Dining Hall. Their fingertip was smashed between a stack of trays and a nearby cart, which was positioned closer than they anticipated. described the initial pain as a four of ten, which later subsided to about a three out of ten over the following days. The finger was bruised at the tip, but the employee did not seek medical attention or treat the injury with ice or other care.		
The employee sustained a minor injury while placing an in/out of office sign on the front of their office door. Their right pinky finger swiped against a nail protruding approximately one inch from the door, causing the finger to bleed. The employee cleaned the wound with hydrogen peroxide and applied a bandage. As a temporary safety measure, the employee covered the exposed nail with tape until it could be removed by Housing Maintenance.
